Bay Mills Community College authorizes some high-performers, but the authorizer has also made several questionable recent authorizing decisions.

- With almost 100 percent low-income students, Hamtramck Academy is ranked near the top 20 percent of all schools in 2013-14.
- Other top performers include American Montessori Academy of Livonia and Wellspring Preparatory High School of Grand Rapids. Both schools ranked among the top ten percent of schools on the 2013-14 state accountability rankings.
- Bay Mills Community College also recently authorized Detroit Community Schools Elementary, among the worst
 charters in Michigan. This school had previously received its charter contract through Saginaw Valley State University,
 but later transferred to Bay Mills Community College. This was despite the school being ranked in the seventh percentile
 statewide in the 2012-13 academic year.
- Other poor performers include Dream Academy and Mildred C. Will Preparatory Academy, both in Benton Harbor. In 2013-14, both schools ranked in the zeroth percentile, meaning that they are two of Michigan's worst performing schools.
